

## Terms & Conditions for Cultpix.com

### Welcome to Cultpix.com!

These Terms & Conditions ("Terms") govern your use of Cultpix.com ("the Service"), an online streaming platform providing subscription video-on-demand ("SVOD") services. By accessing or using the Service, you agree to be bound by these Terms, and you confirm that you are at least 18 years old or have reached the age of majority in your jurisdiction. ## 1. Eligibility and Age Requirement

You hereby consent to the exclusive jurisdiction and venue of the courts of Sweden for all such disputes. Notwithstanding the foregoing, Cultpix AB reserves the right to pursue any legal action in any jurisdiction as may be necessary to enforce its intellectual property rights or to prevent an actual or threatened breach of these Terms and Conditions.
